Detailed description	<p>Starting in March 2025, the mass packaging box for the RUTM51 will be updated as follows:</p> <ul style="list-style-type: none"> • New box dimensions: 360 × 315 × 185 mm (previously 390 × 185 × 185 mm). • Increased shipping quantity: Each packaging box will now contain 20 units instead of the previous 10 units. • Individual packaging: Every RUTM51 unit will now be packed in an individual box before being placed in the packaging box. <p>The visuals below do not represent the actual product packaging; they are for reference purposes only.</p>
