# **Description**



For all ACMA regulatory arrangements, the compliance label is the  $\mathbf{Regulatory}$   $\mathbf{Compliance}$   $\mathbf{Mark}$  ( $\mathbf{RCM}$ ). The RCM replaces the A-Tick and C-Tick compliance marks used under previous regulatory arrangements.

The RCM is a visible indication of a product's compliance with all applicable ACMA regulatory arrangements, including all technical and record-keeping requirements.
